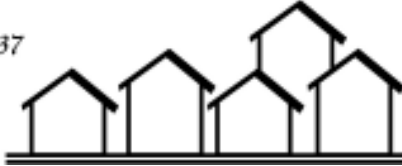

April 3, 2023

The Rossville City Council meeting was called to order on Monday, April 3, 2023 at 6:00 pm by Mayor James Meyer.

Council members present were Trish Heim, Toby McCullough, Dan Glotzbach, Todd Reeves and Taylor Morelli.

Also present were Jeffrey Overmyer, Alan Zlatnik, Yohonna Barraud and Harry Hammer III.

Motion by Taylor Morelli to approve minutes of the March 20, 2023 meeting as written was seconded by Todd Reeves and carried.

Motion by Dan Glotzbach to pay bills as presented totaling \$23,491.20 was seconded by Trish Heim and carried.

Motion by Trish Heim to approve agenda with the addition of hearing for property at 607A Griswold Street was seconded by Todd Reeves and carried.

Code Enforcement Officer Jeffrey Overmyer reported on progress of repairs to property at 607A Griswold Street. Council reviewed remaining issues with Yohonna Barraud. Following discussion motion by Toby McCullough to continue hearing for two weeks until April 17, 2023 was seconded by Todd Reeves and carried.

Douglas Schreiner arrived at 6:14pm.

Code Enforcement Officer Jeffrey Overmyer reported on property at 425 E. Pottawatomie Street. Following discussion, a motion by Toby McCullough to approve resolution regarding the structure at 425 E Pottawatomie Street and setting hearing date of May 15, 2023 at 6:00pm to show cause why the structure should not be condemned was seconded by Dan Glotzbach and carried.

Council discussed progress of crosswalks and sidewalks along Highway 24 with police officer Harry Hammer III.

Mayor reported that police chief applicant Tom Sipp had successfully completed background checks and the City would continue with hiring process.

Utility Superintendent Alan Zlatnik reported that he would be meeting with Bettis Asphalt to look at several locations for street repairs.

Utility Superintendent Alan Zlatnik reported on training and information obtained at Kansas Rural Water conference regarding new lead and copper requirements that go into effect in 2024 and reported on review of locations for bench and fountains for new trail.

Council discussed birds nesting in city park shelters. Zlatnik noted that owls have been purchased and will be put up after buildings are cleaned. Council also noted that bolt was missing from slide in park play area, that bathrooms need to be opened, sand on Main Street needs to be cleaned up, that grass inside pool area needs to be seeded or sod put in and that concrete ditches need to be cleaned. Following discussion council requested that property owners with concrete ditches be reminded that they are responsible to clean the ditches.

Assistant Police Chief Douglas Schreiner reported on property break in that occurred and provided report of statistics reviewing items to include in car video and radar systems; agreement for new police chief; sale of undercover vehicle, abatement notice and school zone signs. Following discussion council to look at ordinance to update school zone signs and adjust lights for next year school session.

Mayor reported on email received from City Attorney Stanley Oyler regarding walking trail. No action was taken.

Council discussed potential new members for Rossville Planning Commission. No action was taken.

Report received about tree with rotten trunk that could pose safety issue. Property owner to be contacted.

Mayor reported on plans for moving viewing deck at Campbell ball field.

Council discussed repairs to drainage ditch at north edge of town. Mayor noted that Shawnee County was to look at having repairs done as soon as property ownership can be determined.

Mayor noted that a rough crossing report has been submitted to Union Pacific Railroad and discussed spraying of weeds along railroad.

Council had discussion and reviewed changes to Tall Corn Festival to move street dance to Friday night and car show and other activities to Saturday.

Council discussed getting dumpster for city cleanup. No action was taken.

Motion by Todd Reeves to adjourn was seconded by Toby McCullough and carried. Meeting adjourned at 7:20pm.
