

The Rossville City Council meeting was called to order on Monday, April 5, 2021 at 6:59 pm by Mayor Kenneth Wichman using online Zoom meeting.

Council members present via Zoom were Trish Heim, Dan Glotzbach, James Meyer, Toby McCullough and Christi McKenzie.

Also present via Zoom were Tracey Taylor, Alan Zlatnik, Randy Dick and Jason Connell.

Motion by Trish Heim to approve minutes of the March 15, 2021 meeting as written was seconded by Dan Glotzbach and carried.

Motion by Dan Glotzbach to pay bills as presented totaling \$56,224.80 was seconded by Toby McCullough and carried.

Motion by Trish Heim to approve agenda with addition of Randy Dick was seconded by James Meyer and carried.

Matt Conner was on agenda to discuss crosswalk. Matter was tabled as Matt Conner was not present.

James Meyer inquired about identifying meeting attendees when conducting meetings by zoom. Clerk explained that City zoom meeting administrator had information on all attending.

Council discussed resuming in person council meetings. Following discussion council agreed to resume in person meetings starting April 19, 2021 with all attending being required to wear masks.

Utility Superintendent Alan Zlatnik reported that he was getting bids for painting of water tower. Zlatnik also reported that the old concession building at Campbell Baseball Stadium needed roof replaced and presented bid. Council requested that Zlatnik get another bid for concession roof replacement.

Toby McCullough inquired about sidewalks needing replacement due to the installation of water meters. Zlatnik noted that there were app 11 areas that would require concrete to repair sidewalks and that they would be having Stum's Concrete repair.

Council had discussion regarding concrete ditches along Perry Street and Griswold area. Following discussion council instructed that the utility department clean ditches in 2021 and then notify property owners by mail that cleaning of ditches are not the responsibility of the City and that property owners will need to keep the ditches free of debris and grasses in the future.

Christi McKenzie inquired about sprinklers on swimming pool property. Alan Zlatnik reported that sprinklers were being worked on.

Police Chief Jason Connell attempted to have video from Sheriff Hill played for council but due to technical difficulties was unable to play so reported on statement from Sheriff Hill regarding joint drug task force activities.

Chief Connell noted that ramp at police department and roof both need repairs. Following discussion council requested that contractors bidding on concession building be asked to add police station roof to bid.

Mayor reported on quote from Blue Cross Blue Shield of Kansas for employee health insurance coverage and noted that Randy Dick was presented to discuss employee health insurance.

Randy Dick requested permission to gather information to provide the City with quotes for employee health insurance coverage. Council agreed to provide Dick with information needed for quotes. Randy Dick also noted that they are nearing completion of the renovations to their offices on Main Street and invited council to visit and see renovations.

Clerk presented request for water bill adjustment due to leak at 220 W Adrian Street. Motion by Dan Glotzbach to adjust by half the overage was seconded by Toby McCullough and carried.

Assistant City Clerk Tracey Taylor provided information on Collection Bureau of Kansas (CBK) and reported on the delinquent water service bills and court payments. Following discussion council agreed to have CBK give council a presentation.

Toby McCullough reported that the Rossville Community Foundation was wanting to partner with the City to update the north and south City limit signs and was getting ideas and quotes.

Motion by Trish Heim to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 7:48pm.
