Motion by Dan Glotzbach to pay bills as presented totaling \$94,589.98 was seconded by Trish Heim and carried.

Motion by Christi McKenzie to approve agenda as written was seconded by James Meyer and carried.

Mayor reported that owner of property at 615 W. Maple Court had applied for permit to move building from property and that building has been removed. Council requested that Code Enforcement Officer Jeffrey Overmyer be requested to review fence construction at 615 W. Maple Court to ensure that height requirements are being met.

Utility Superintendent Alan Zlatnik reported that there are a lot of vehicles being parked on the property along Highway 24 across from Casey's General Store. Following discussion Police Chief Jason Connell reported that he would contact owners and request that vehicles be removed.

Council had discussion with Utility Superintendent Alan Zlatnik about work hours for part time utility employees. Zlatnik reported on number of new meters that have been installed; that Shawnee County had swept Main Street and that the purchase of new utility truck has been delayed due to coronavirus shut down.

Police Chief Jason Connell reported that the 2012 truck had been repaired and would be sold or traded to Brown's Chevrolet. Chief Connell reported on vehicle he would like to purchase to be used by the police department. Following discussion motion by Dan Glotzbach to approve trading 2012 truck and \$4,500 for purchase of vehicle was seconded by Christi McKenzie and carried.

Police Chief Jason Connell reported on the police department status and policies due to COVID-19 situation.

Clerk reported that Zito Media had not returned calls regarding removal of cable TV boxes.

Mayor reported that quote for renewal of employee health insurance from Blue Cross and Blue Shield had been received and that rates had increased. Mayor noted that he had contacted Blue Cross and Blue Shield regarding proposals to lower rates and that Bukaty Co was reviewing employee information for possible proposal. Mayor noted that the City may need to change current coverage and/or require employees to pay a portion of premium to keep cost within budget.

Council had discussion regarding actions due to COVID-19 and the possible financial impact on the City and noted that meetings would continue to be conducted using ZOOM as long as necessary. Information on meeting
