City Hall August 17, 2020

The Rossville City Council 2021 budget hearing was called to order at 7:00 pm on Monday, August 17, 2020 by Mayor Kenneth Wichman using online Zoom meeting.

Clerk reported that the proposed 2021 budget would reflect a mill levy decrease to 38.6 mills with a total ad valorem tax of \$295,280.00.

Following the closing of the 2021 budget hearing the Rossville City Council meeting was called to order at 7:03 pm by Mayor Kenneth Wichman.

Council members present via Zoom were Trish Heim, James Meyer, Dan Glotzbach and Christi McKenzie. Travis VanVleck was absent.

Also present via Zoom were David DeVore, Brad Kirk, Jason Connell and Alan Zlatnik.

Motion by Dan Glotzbach to approve minutes of the July 20, 2020 meeting as corrected was seconded by James Meyer and carried.

Motion by Trish Heim to pay bills as presented totaling \$76,068.46 was seconded by Dan Glotzbach and carried.

Motion by Trish Heim to approve agenda as presented with spelling correction was seconded by Don Glotzbach and carried.

David Devore of BG Consultants was present to review contract with the City for preliminary architectural report on park bathroom and storm shelter at a cost of \$6,200.00. Following discussion motion by Dan Glotzbach to approve contract contingent upon approval by City Attorney was seconded by Christi McKenzie and carried.

Mayor Wichman reported that councilmember Travis VanVleck had contacted him and advised that due to school and family commitments he would be resigning as council member as soon as the Mayor could find a replacement. Mayor requested that anyone interested or know someone that might be interested in serving as City Council member to contact him.

Utility Superintendent Alan Zlatnik reported that they would be getting more mulch for the playground area soon, that part time summer employee may work a few Saturday's to help with putting in new water meters, but was done for the summer and that they would continue with mosquito spraying at least once per week.

Police Chief Jason Connell reported on work comp claim for officer.

Council reviewed final contract with Beyond Baseball for lease of baseball park from May 20, 2021 to August 7, 2021. Motion by Dan Glotzbach to approve contract as presented was seconded by Christi McKenzie and carried.

Mayor appointed Trish Heim as member of the Shawnee County Solid Waste Management Committee. Motion by James Meyer to approve appointment was seconded by Christi McKenzie and carried.

Motion by Dan Glotzbach to approve the 2021 Budget as presented in hearing was seconded by Trish Heim and carried.

James Meyer inquired about sales of products in Andrick park by individuals without license. Council noted that as per City Code those individuals would be considered a peddler and would require a city license.

Clerk presented request for water bill adjustment at 628 Griswold due to leak. Motion by James Meyer to approve adjustment by half the overage was seconded by Trish Heim and carried.

Council reported problem with trash accumulation in dumpsters along Griswold apartments. City to check with Shawnee county refuse about any issues.

Motion by Trish Heim to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 7:48pm.
