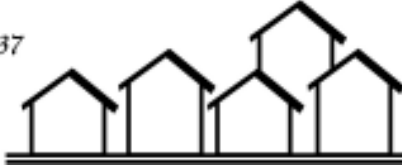

August 7, 2023

The Rossville City Council meeting was called to order on Monday August 7, 2023 at 6:00 pm by Mayor James Meyer.

Council members present were Trish Heim, Dan Glotzbach, Todd Reeves, Rick Towers and Vern Sumner.

Also present was Thomas Sipp, Alan Zlatnik and Jeffrey Overmyer.

Motion by Trish Heim to approve minutes of the July 17, 2023 meeting as written was seconded by Todd Reeves and carried.

Motion by Dan Glotzbach to pay bills as presented totaling \$66,864.50 was seconded by Trish Heim and carried.

Motion by Trish Heim to approve agenda with addition of Jeffrey Overmyer was seconded by Todd Reeves and carried.

Code Enforcement Administrator Jeffrey Overmyer reported on building code violations at 205 E Hwy 24 Trafficway and 416 Navarre. Overmyer also discussed with council pending steps to vacate property at 425 E Pottawatomie due to property being condemned and declared unfit for human habitation. Overmyer will continue to address code violations and consult with City Attorney on property at 425 E Pottawatomie.

Mayor reported that MDA benefit softball tournament held in Rossville was a success raising around \$61,000.00.

City Utility Superintendent Alan Zlatnik reported that there were no problems during MDA tournament. Zlatnik reported that there were some ruts in park grass due to campers but damage could have been worse if it had rained. Zlatnik noted that if the weather is wet or rainy then holding softball tournament the weekend before Tall Corn Festival could result in damage to the park grounds for Tall Corn Festival activities.

Utility Superintendent Alan Zlatnik reported that a combination lock has been put on the gate at the forestry dump. The code will only be given to Rossville residents for the purpose of dumping forestry items removed from Rossville properties. To get code Rossville residents can call City Hall.

Change of easement request for 144 Main was presented. Council noted that this would need approval by Shawnee County.

Mayor, council and Utility Superintendent Alan Zlatnik discussed getting written confirmation from Kansas Gas Service that gas line under drainage ditch along the Catholic church property has been abandoned and is no longer in use.

Police Chief Thomas Sipp reported on activities and actions taken by the Rossville Police Department including the hosting of a radar instructor class and working with Shawnee County to reactivate the license plate readers at the police station.

Clerk presented final draft of 2024 budget for review.

Resolution ADDING COMPENSATORY TIME TO SECTION D-6 OVERTIME COMPENSATION IN THE PERSONNEL POLICY AND GUIDELINES, CITY OF ROSSVILLE, KANSAS was presented. Motion by Dan Glotzbach to adopt resolution was seconded by Todd Reeves and carried.

Mayor reported that Wehner's of Rossville would be providing the corn for the Tall Corn Festival corn eating contest. Contest to be at 7pm on Saturday, August 12, 2023.

Motion by Todd Reeves to approve beer garden license for the Rossville American Legion Post #31 for the City Park and Main Street from August 11, 2023 to August 14, 2023 was seconded by Trish Heim and carried.

Motion by Dan Glotzbach to adjourn was seconded by Rick Towers and carried. Meeting adjourned at 7:23pm.
