

Clerk presented application from Mikey's Bar and Grill for drinking establishment license. Motion by Dan Glotzbach to approve license was seconded by Trish Heim and carried.

Clerk presented application from Rossville Liquor for liquor store license. Motion by Trish Heim to approve license was seconded by Dan Glotzbach and carried.
