Motion by Rick Towers to go into executive session for 15 minutes to discuss personnel was seconded by Trish Heim and carried. Executive session to be from 6:09 to 6:24 pm with mayor and council attending.

Council reconvened in open session at 6:24pm.

Utility Superintendent Alan Zlatnik reported that with additives purchased from Continental Research and Dawn dish soap the problems in the lift station on Griswold Street have been better in the past three years.

Mayor reported that he talked to White Star about purchasing excavator and they are checking to see if the City would qualify for 40% government discount on purchase of new machine.

Utility Superintendent Alan Zlatnik reported on clothing and cold weather gear provided to utility department personnel in other municipalities. Following discussion motion by Todd Reeves to purchase gear for new utility employee was seconded by Rick Towers and carried.

Police Chief Thomas Sipp reported on equipment and installation costs for replacement of pedestrian crosswalk signals on Highway 24 and one year extended warranty for police cameras.

Chief Sipp presented report of police activities and noted that repairs at police station had begun.

Chief Sipp reported that Assistant Chief Schreiner had reviewed animal ordinances and presented copy of suggested changes. No action was taken.

Mayor reminded council that City holiday dinner would be December 13, 2023.

Motion by Todd Reeves to adjourn was seconded by Vern Sumner and carried. Meeting adjourned at 7:01pm.
