Mayor reported on receipt of CARES money in the amount of \$71,947.64.

Christi McKenzie thanked the RCDC Committee for putting on the Christmas Festival. She also thanked PRIDE for decorating the windows in the building at the north end of Main Street. Thanks was also given to Toby and Ann McCullough for sweeping up leaves on Main Street.

Utility Superintendent Alan Zlatnik thanked the City workers for putting up the Christmas decorations. He also reported that they scrapped the old meters and received around \$2,300.00.

Council had discussion regarding grain bins on railroad property. Following discussion Mayor Wichman noted that he would contact owner and inquire about plans.

Toby McCullough expressed concerns about concrete chunks found on sidewalk in front of old hardware store. Clerk noted that she had advised Code Enforcement Administrator Jeffrey Overmyer about concrete and he was going to check on structure.

Utility department noted that the bridges south of Rossville across Cross Creek have been removed by Shawnee County contractor.

Mayor reported that he did not have any new information on the drainage ditch.

Police Chief Jason Connell advised that he had no information to report.

Motion by Trish Heim to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 7:23pm
