

Alan Zlatnik joined meeting.

Scott Hammer was present to request permission to host a two-mile fun color run to benefit Cody Lambotte on March 20. Run will use the same route used for tall corn festival run. Following discussion motion by Dan Glotzbach to allow run was seconded by Trish Heim and carried.

Council had discussion regarding proposal from beyond Baseball for changes to Campbell field. Mayor to schedule meeting with Titus Bond of Beyond Baseball to further review proposal.

Mayor appointed Stanley Oyler as City Attorney. Motion by James Meyer to approve appointment was seconded by Toby McCullough and carried.

Mayor appointed Alan Streit as Municipal Court Judge. Motion by Trish Heim to approve appointment was seconded by Dan Glotzbach and carried.

Mayor appointed Tami Eustice as City Treasurer. Motion by James Meyer to approve appointment was seconded by Christi McKenzie and carried.

Motion by Toby McCullough to appoint James Meyer as council president was seconded by Trish Heim and carried.

Council discussed design for park restroom/storm shelter. Final report to be provided by BG Consultants.

Council had discussion about changing main bank account to Flint Hills State Bank from US Bank as Rossville US Bank is still not reopened. No action was taken.

Toby McCullough noted that Rossville Community Foundation would be interested in partnering with the City to upgrade the north and south City welcome signs. Following discussion council noted they would be open to idea of changes to signs.

Utility Superintendent Alan Zlatnik reported that he was working on plans for painting of water storage tank this year.

Utility Superintendent Alan Zlatnik reported that there have been problems with grease in the Griswold Street lift station and that they were trying some new products in hopes of reducing problems and that he would be consulting with Kansas Rural Water representative about other ideas to reduce grease issues.

Council discussed grass area around pool and rain garden at park. Utility department to address grass area at pool and are looking at some solutions to rain garden issues.

Police Chief Jason Connell reported on increase in traffic citations issued and noted that a lot are registration violations due to confusion with COVID delays. Chief Connell also noted that several investigations were completed and that he was waiting on warmer weather to address some of the city code violations. Council also discussed completion of fence and sidewalk at Thederahn property.

Council asked Chief Connell what his plans were to keep the police department within budget in 2021. Chief Connell reported on issues and plans.

Assistant Clerk Tracey Taylor requested permission to attend remote Spring Court Clerk Conference at cost of \$225.00. Motion by James Meyer to allow Taylor to attend was seconded by Toby McCullough and carried.

Assistant Clerk Tracey Taylor reported on changes to City website.

Motion by Dan Glotzbach to adjourn was seconded by Toby McCullough and carried. Meeting adjourned at 8:28pm.
