Motion by Christi McKenzie to pay bills as presented totaling \$41,742.63 was seconded by Dan Glotzbach and carried.

Motion by Christi McKenzie to approve agenda as corrected was seconded by Trish Heim and carried.

Titus Bond of Beyond Baseball was present. Mayor reported that in person meeting with Titus Bond, City personnel and Rossville Jr/Sr High school personnel went well and that he would recommend the City allow Beyond Baseball to make improvements to Campbell field as presented with the exception of the party decks. Following discussion with Titus Bond council approved changes. Mayor to send written approval to Beyond Baseball.

Tom Fulmer and Gary Aufdemberg of Wamego Telecommunications WTC were present to request City Council endorsement of plans to start pre-sign up of Rossville residents in order to bring fiber services to Rossville. Following discussion council endorsed plans by WTC.

Clint Hibbs and Elizabeth Verhaeghe of BG Consultants presented preliminary architectural report and discussed options for design of Restroom/Storm Shelter in the City park. Following discussion Hibbs reported that he would prepare design plans for final review in 15-30 days.

Utility Superintendent Alan Zlatnik reported on grease issues at Griswold sewer lift station and noted that after touring lift station with Kansas Rural Water representative Charlie Schwindamann they would be sending sewer samples in for analysis.

Superintendent Alan Zlatnik reported that he was working on prices and options for painting of water standpipe.

Council inquired about any issues due to cold temperatures. Superintendent Zlatnik reported that the City had not experienced any at this time.

Police Chief Jason Connell reported that the warranty on the police body and vehicle cameras was coming due and he would present price for renewal at next meeting.

Council reviewed email correspondence from owner of the grain elevators located along Highway 24. No action was taken.

Councilmember McCullough inquired about vehicle seat at Andrick Park. Superintendent Zlatnik reported that seat had been left by unknown persons and that he would remove.

Chief Connell noted comments by attendees of meeting regarding restroom/storm shelter. Following discussion, no action was taken.

Motion by Christi McKenzie to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 8:37pm.
