Due to the holiday on Monday the Rossville City Council meeting was called to order on Tuesday, February 20, 2024 at 6:00 pm by Mayor James Meyer.

Motion by Dan Glotzbach to pay bills as presented totaling \$126,426.33 was seconded by Todd Reeves and carried.

Motion by Todd Reeves to approve agenda with the addition of Myron Leinwetter was seconded by Dan Glotzbach and carried.

Myron Leinwetter was present to update City Council on the Rossville Community Foundation Trails; Safe Routes to School program with KDOT as well as KDOT (TEAP) Traffic Engineering Assistance Program; BCBSKS Pathways to a Healthy Kansas Initiative and Union Pacific Railroad. No action was taken.

Utility Superintendent Alan Zlatnik reported that poles at ball field have been set and the lights will be tested tomorrow night. Zlatnik noted that one pole had to be installed close to Parkway Street due to underground utilities.

Superintendent Zlatnik noted that the City had received some complaints about discolored water and would be flushing the fire hydrants tomorrow to help this issue.

Superintendent Zlatnik reported that the water service line inventory questionnaires have been sent out and some have already been returned to City Hall. Anyone with questions can contact him or City Hall for assistance in completing these questionnaires.

Police Chief Thomas Sipp reported on items completed by the police department including investigation of discharge of explosive device, issuance of ATV/Utility vehicle permit for commercial use, assisting fire dept with fire at 416 Navarre and working with Matt Stormer of KDOT on crosswalk project. In addition, Chief Sipp requested approval to proceed with purchase of new security cameras from WTC at a cost of \$5,776.50 for camera's and \$91.10 per month for maintenance. Following discussion motion by Todd Reeves to approve purchase of cameras and maintenance fees was seconded by Vernon Sumner and carried.

Motion by Todd Reeves to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 6:38 pm.
