

The Rossville City Council meeting was called to order on Monday, July 18, 2022 at 6:00 pm by Mayor James Meyer.

Council members present were Todd Reeves, Trish Heim and Toby McCullough. Dan Glotzbach and Taylor Morelli were absent.

Also present were Chad Shafstall, Brad Kirk, Shelly Robertson and Jason Connell.

Motion by Trish Heim to approve minutes of the July 5, 2022 meeting as written was seconded by Todd Reeves and carried.

Motion by Toby McCullough to pay bills as presented totaling \$39,474.37 was seconded by Trish Heim and carried.

Motion by Toby McCullough to approve agenda with addition of Chad Shafstall was seconded by Trish Heim and carried.

Shelly Robertson of Margarita Express was present to request permission for sale of margarita's and bloody mary's in City Park during Tall Corn Festival celebration. Following discussion motion by Todd Reeves to approve sale of alcoholic beverages in City Park during Tall Corn Festival provided that vendor works with Rossville Community Development Committee in complying with all regulations was seconded by Toby McCullough and carried.

Chad Shafstall was present to give information to the council regarding city cleanup. Shafstall noted that location of dumpsters worked well and that he hauled \$96.00 of scrap that he will use to purchase 50 pool passes along with another 50 passes that he will donate to be distributed to kids in the community. Shafstall made suggestions such as having equipment available to compact items and noted that it would be nice to have another such event in the fall. No action was taken.

Utility Employee Brad Kirk reported that the utility department is getting ready for Tall Corn Festival and that Catron Construction started shelter house repairs today.

Kirk reported that contractors cleaning sewer lines located area of concern in main line at E. Perry and Navarre that may require repair.

Police Chief Jason Connell reported on code compliance issues and thanked those that helped with dumpsters during cleanup.

Mayor continued employee discussion of salary review until next regular meeting.

Council reviewed draft of 2023 budget setting mil levy at 47.984 and noted that City would exceed the revenue neutral rate set by the county. Council approved draft. Notice to be sent to Shawnee County Clerk.

Mayor reported on progress of exercise trail lease agreement with Doug French.

Clerk provided information on Kansas Gas Service franchise renewal. Following discussion council requested that franchise agreement be prepared using a franchise fee of 3%.

Council had discussion regarding spraying of weeds on railroad tracks.

Council discussed city newsletter.

Motion by Trish Heim to adjourn was seconded by Todd Reeves and carried. Meeting adjourned at 6:49pm.
