Motion by Trish Heim to pay bills as presented totaling \$33,746.44 was seconded by Toby McCullough and carried.

Motion by Dan Glotzbach to approve agenda as presented was seconded by Trish Heim and carried.

Doug French was present and provided information on the name "Toadstrangler" and detailed his support of the community. Following discussion motion by Trish Heim to proceed with contract for exercise trail using name of "Toadstrangler Trail" was seconded by Toby McCullough and carried.

Council reviewed draft of 2023 budget and expressed desire to have 2023 mil levy stay same as 2022.

Utility Superintendent Alan Zlatnik reported that he had received email from McGuire Iron confirming that repair to spot identified on water storage tank would be done at later date. Payment has been forwarded to McGuire Iron for painting of storage tank.

Superintendent Zlatnik noted that Catron Construction would begin repairs to park shelter house as soon as materials arrive. Repairs should be completed before Tall Corn Festival celebration.

Superintendent Zlatnik noted that speed limit sign along E. Perry Street had not been installed yet as someone keeps removing location flag placed for line locates.

Council inquired about tires on railroad tracks east of police station. Superintendent Zlatnik to check.

Police Chief Jason Connell presented information on code compliance issues and noted that dumpsters would be delivered to the police station on July 8th for use by residents.

Toby McCullough reported on progress of stone for south city limit sign.

Mayor appointed Taylor Morelli as park commissioner. Motion by Dan Glotzbach to approve appointment was seconded by Trish Heim and carried.

Brooke Hase was present and requested permission to license more than 3 dogs at 610 Pearl. Following discussion council denied request to allow 4 dogs and advised that after all dogs reach 6 months of age only 3 may remain at 610 Pearl.

Motion by Dan Glotzbach to adjourn was seconded by Taylor Morelli and carried. Meeting adjourned at 7:15pm.
