Motion by Dan Glotzbach to pay bills as presented totaling \$31,996.46 was seconded by Toby McCullough and carried.

Motion by Christi McKenzie to approve agenda as written was seconded by James Meyer and carried.

Mayor noted that he had missed the last couple meetings due to health issues.

Mayor noted that WTC were working in Rossville in various locations.

Clerk reported that Beyond Baseball has made payment of lease and would still owe \$500.00 after applying deposit. Council had discussion regarding problems with locations of bull pens and type of fencing used. No action was taken.

Utility Superintendent Alan Zlatnik reported that Shawnee County would be addressing the drainage culvert issue at 239 Main Street.

Superintendent Zlatnik noted that there may be issues with fences that were constructed in alley easement in the 200 block of Main/Navarre as WTC work to run lines.

Superintendent Zlatnik reported that the annual sewer cleaning was starting this week. One third of the towns main sewer lines are cleaned each year on a rotating basis.

Superintendent Zlatnik reported that they have been spraying for mosquitos and would be spraying again tonight.

Superintendent Zlatnik presented park maintenance schedule and reported that the park play equipment has been power washed. Council noted that the park was looking great. Zlatnik noted that the tree stumps would need to be removed and that he was looking at planting maple tree in the area where the pine trees had been.

Police Chief Jason Connell reported that tomorrow the police department would issue citations to code violations that have not been resolved.

Chief Connell also reported that there had been no issues with 4th of July celebrations or Silver Lake celebration at the Legion.

Toby McCullough reported that he had bid from Brandon Bergstresser to construct Rossville City limit signs at north and south entrances to town. Cost would be \$2,850.00 for each sign or \$3,250.00 for each sign plus footings. McCullough reported that the Rossville Community Foundation would consider cost sharing on this project. Council had discussion regarding location of north sign if repairs made to drainage ditch. No action was taken at this time.

Council reviewed 2022 budget numbers for the general fund. No action was taken.

Motion by James Meyer to adjourn was seconded by Toby McCullough and carried. Meeting adjourned at 8:10pm.
