Motion by Dan Glotzbach to pay bills as presented totaling \$74,623.02 was seconded by Trish Heim and carried.

Motion by James Meyer to approve agenda as written was seconded by Dan Glotzbach and carried.

Trish Heim reported that she had consulted with Wamego Telecom representative back in August regarding offering services to Rossville. WTC had indicated that they would need at least 70% of the town registered before they would start putting in lines and the earliest they would consider starting would be in 2021.

Jason Connell arrived at 7:04pm.

Christi McKenzie arrived at 7:07pm.

Utility Superintendent Alan Zlatnik reported that his department would be opening the bathrooms in the park; that the barricades would come down on Navarre Street Wednesday after street repair; and that they have installed approximately 140 new radio read water meters and have approximately 300-350 left to install.

Mayor reported that he had been contacted by property owner at 239 Main regarding sewer issues and that the utility department had check sewer main and flushed main with assistance from the fire department and found no issues with the main sewer in the area.

Police Chief Jason Connell reported on issue with resident adding additional signage to stop signs at Pearl and Parkway and requested that the utility department remove additional signs. Clerk noted that signs are now noncompliant with the manual on uniform traffic control devices (MUTCD) and that resident putting up additional signage is in violation of section 6.10 of the standard traffic ordinance "tampering with a traffic signal". Council instructed utility superintendent to have signs removed and taken to City Hall.

Police Chief Jason Connell reported that the police department was starting to resume normal operations with additional precautions in place for COVID-19.

Council had discussion regarding after prom committee request to use City park for activity. Matter tabled until later in the meeting for more information.

Chief Connell noted that reports had been received regarding vehicles that had been gone through overnight.

Council had discussion regarding the resolution of code violations at 615 Maple Court. No action was taken.

Christi McKenzie reported that the Rossville Community Foundation would meet in July and she would address funding assistance for preliminary architectural report to construct new park bathrooms and storm shelter.

Clerk reported that Code Enforcement Administrator Jeffrey Overmyer had checked on updating building code books and found that several will have new additions in 2021 and proposed that the City wait to update until new books are available.

Council thanked Christi McKenzie for giving speech and representing the City at the Shawnee County Commission meeting to address repairs to the swimming pool and noted that the Shawnee County Commissioners voted to proceed with repairs to the pool and open when repairs are complete.

Mindy Fielder and Kelly Kenney arrived at 7:36 pm.

Mindy Fielder and Kelly Kenney answered questions regarding activity planed for Rossville High School students that were unable to have prom. Committee would like to hold event at the City Park July 16, 2020 from 7 to 10pm and would comply with COVID-19 regulations. Motion by Dan Glotzbach to allow committee to hold event in park was seconded by James Meyer and carried.

Council expressed thanks to Bob Larson for painting lion statues in park and on Main Street.

Motion by Dan Glotzbach to adjourn was seconded by Trish Heim and carried. Meeting adjourned at 7:46pm.
