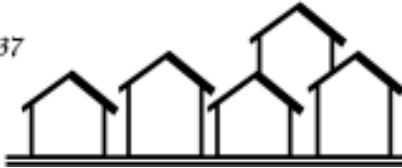

Mayor presented copy of emails from Shawnee County Emergency Management regarding drainage ditch.

Jason Connell arrived at 7:07 pm.

Utility Superintendent Alan Zlatnik reported on bid from Bettis Asphalt for street overlay projects.

Utility Superintendent Alan Zlatnik reported that he had several applicants for summer employee position and discussed option of extending hours for part time utility employee position. Following discussion council requested that Zlatnik start accepting applications for summer employee position.

Utility Superintendent Alan Zlatnik reported on truck repairs and cost of new utility truck. No action was taken.

Utility Superintendent Alan Zlatnik noted that some digging had been done at the swimming pool by company hired by Shawnee County to do repairs.

Police Chief Jason Connell reported that his department is working on code violations and one citation was issued today.

Council had discussion regarding complaint received about condition of abandoned cable boxes throughout town. Clerk reported that she had contacted Zito Media and was told that they would have someone return call.

Clerk presented request for water bill adjustment for 715 Citizen Circle due to leak. Motion by James Meyer to approve adjustment by half the overage was seconded by Christi McKenzie and carried.

Council discussed dates for annual city-wide garage sales. Following discussion council set dates for May 8<sup>th</sup> and 9<sup>th</sup>.

Council discussed city-wide clean up. Chief Jason Connell volunteered to organize event. Council set June 4<sup>th</sup> as starting day for city-wide clean up.

Motion by Trish Heim to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 8:07 pm.
