Motion by Dan Glotzbach to pay bills as presented totaling \$48,854.70 plus insurance premium of \$30,764.00 was seconded by Toby McCullough and carried. Motion by Dan Glotzbach to use capitol improvement funds to pay for upgrades to sprinkler system and reseeding/fertilizing of swimming pool grass area was seconded by Trish Heim and carried.

Motion by Christi McKenzie to approve agenda as written was seconded by Dan Glotzbach and carried.

Tom Harpin of BG Consultants presented draft of plans for park bathroom/storm shelter. Council reviewed draft and consulted with Harpin on design plans and cost estimate.

Council reviewed draft of contract with WTC Telecommunications, Inc. to provide video service in the City of Rossville. Matter was tabled until next regular meeting.

Utility Superintendent Alan Zlatnik reported that WTC had vehicles in town and they have advised him that they will start working in the Debo Trailer park area.

Utility Superintendent Alan Zlatnik reported that he was to meet with contractor tomorrow regarding additional bid for painting of water standpipe and that the rock had been removed, sprinklers worked on and area seeded at the swimming pool.

Council discussed Shawnee County Refuse totters that had been delivered to Griswold Street apartments. No action was taken.

Utility Superintendent reported that a power surge at the Griswold Street sewer lift station had caused the system to fail. Repairs have been made and insurance claim filed with the City insurance provider.

Christi McKenzie inquired about painting of parking stalls at library. Zlatnik reported that Shawnee County would need to be contacted.

Police Chief Jason Connell reported that he was in training last week and discussed code enforcement items needing to be addressed.

Council inquired about any complaints regarding the City not holding a city clean up event. Clerk reported that no complaints were received at City Hall.

Council discussed cleaning of ditches and problems with ditches being filled with leaves/grass.

Toby McCullough reported that he was still getting ideas/bids for north and south city limit signs.

Council President James Meyer reported that the Mayor and City Attorney Stanley Oyler would be meeting with Myron Leinwetter of the Rossville Community Foundation at City Hall on Wednesday, May 19, 2021 to discuss liability and leasing issues in regards to the walking trails. Clerk to email council to confirm time of meeting.

Christi McKenzie inquired about swimming pool contract expiration. Clerk to check contract.

Clerk presented application from Fastdraws for license to operated one music machine and six amusement machines. Motion by Toby McCullough to approve license was seconded by Christi McKenzie and carried.

Council discussed sidewalk at 615 Maple Court. No action taken.

Motion by Trish Heim to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 8:35pm.
