The Rossville City Council meeting was called to order on Monday, May 2, 2022 at 5:58 pm by Mayor James Meyer.

Council members present were Dan Glotzbach, Todd Reeves, Trish Heim and Toby McCullough.

Also present were Alan Zlatnik, Jason Connell and Brandon Mildren.

Motion by Toby McCullough to approve minutes of the April 18, 2022 meeting as corrected was seconded by Trish Heim and carried.

Christi McKenzie arrived at 5:59pm.

Motion by Dan Glotzbach to pay bills as presented totaling \$84,800.91 was seconded by Christi McKenzie and carried.

Motion by Trish Heim to approve agenda as written was seconded by Toby McCullough and carried.

Brandon Mildren representing the Rossville Christian Church was present to report that the Church was considering purchasing property west of Wehner's Thriftway to construct a large facility with recreational gym and meeting space and wanted to check on zoning for this location. Mildren noted that construction could take up to 5 years to complete. Following discussion council requested time to consider zoning restrictions and construction time line.

Christi McKenzie presented letter of resignation as Rossville City Council member. Mayor requested that anyone interested in being appointed as City Council member to complete term should contact him.

Utility Superintendent Alan Zlatnik reported that quote to construct lay down curb for handicapped access in front of the library would be \$3,000.00. Following discussion motion by Dan Glotzbach to accept quote and proceed with construction of curb cut with Jeffrey Overmyer inspecting for handicapped compliance was seconded by Todd Reeves and carried.

Superintendent Zlatnik reported that lights are up at ball field and his department has started applying linseed oil to playground structure.

Superintendent Zlatnik reported on water tank painting and issues and advised council that he had purchased variable speed drive for second pump at cost of \$1800.00. Zlatnik also reported that the master meter has stopped working and that he has reported issue to KDHE and was working with them on extension of time to replace or repair meter until water tank maintenance has been completed.

Toby McCullough reported missing sign, flashing light not working and pot hole near 612 Kross Circle.

Superintendent Zlatnik reported that summer employee will not be returning this year. No action was taken.

Police Chief Jason Connell reported that he had two part time police officers' positions vacant at this time and requested that council review starting pay for this position. Clerk to prepare list of current employee salaries for next meeting.

Chief Connell reported that due to the age of the police vests he would like to purchase seven new vests at cost of \$750.00 to \$1100.00 per vest. Purchase to be made using asset forfeiture funds.

Chief Connell requested permission to replace three shotguns from Atlantic Tactical at a cost of \$9,583.95. Chief Connell recommended using VIN Inspection funds for purchase. Clerk noted balance in VIN Inspection fund is \$3,864.05.

Motion by Dan Glotzbach to proceed with purchase of seven police vests was seconded by Christi McKenzie and carried.

Motion by Todd Reeves to allow police department to purchase three shotguns using funds in VIN inspection fund and asset forfeiture funds and to sell old shotguns was seconded by Toby McCullough and carried.

Council discussed employee salary review.

Council inquired about security cameras. Chief Connell to check on prices.

Mayor reported on signs at ball field.

Mayor reminded council of law enforcement candlelit vigil and memorial ceremony May 5 and 6th.

Mayor noted that workers compensation claim filed with Berkshire Hathaway Insurance had been denied.

Trish Heim reported on information regarding free dump day and reminders to not put glass in recycle containers. Information to be put on city website/Facebook.

Council thanked RCDC and 4H for planting flowers in pots on Sunday.

Motion by Trish Heim to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 7:34pm.
