City Hall November 1, 2021

Motion by Dan Glotzbach to pay bills as presented totaling \$33,721.20 was seconded by Toby McCullough and carried.

Motion by James Meyer to approve agenda as written was seconded by Trish Heim and carried.

Mayor Wichman reported that City Attorney Stanley Oyler had inquired about whether the City or Foundation would pay for survey to complete agreement for recreational exercise trail. Following discussion council noted that the City is already paying City Attorney legal fees. Council requested more information on cost of survey.

Utility Superintendent Alan Zlatnik reported on damage to light pole banner by construction company working at the library and provided cost estimates for repairs.

Superintendent Zlatnik reported that he had met with representative from Kent Fencing and was getting bids for netting solutions to elevated deck, bull pens and back stop.

Superintendent Zlatnik reported that the sewer line under the sidewalk along Navarre Street would need to be dug up and replaced.

Police Chief Jason Connell reported on final disposition of \$30,000.00 in drug seizure monies from 2018 case and requested approved to use \$13,500.00 for update to cameras. Following discussion council tabled matter until more information can be obtained on proposed camera system.

Discussion of letter to railroad regarding sidewalks at Anderson Street crossing was tabled.

Council noted that south city limit sign is still waiting to be sandblasted.

Request from employees to trade day off for Veteran's Day with November 26, 2021was presented. Motion by James Meyer to approve request was seconded by Toby McCullough and carried.

Change of easement request for 249 Navarre was presented. Motion by Toby McCullough to approve request was seconded by Dan Glotzbach and carried.

Council inquired about permit for work at 609 Griswold St. Clerk reported that Code Enforcement Officer Jeffrey Overmyer had approved fence and driveway permit at this location.

Motion by Toby McCullough to adjourn was seconded by Trish Heim and carried. Meeting adjourned at 7:45pm.
