Motion by Dan Glotzbach to approve agenda with removal of Mark Brockamp was seconded by James Meyer and

Morgan Hansen of Rossville Community Development Committee was present to report on plans for the Christmas Festival scheduled for December 11, 2021 and to request permission to close Main Street from 7:45 to 9:30 pm for parade. Hansen also invited Mayor and City Council to be participants in parade and inquired about assistance with cash prize money for Christmas decorating/lighting contest. Following discussion motion by Dan Glotzbach to close Main Street for parade on December 11 as needed for parade was seconded by Toby McCullough and carried. Motion by Trish Heim to donate \$300.00 to RCDC for use as prize money for decorating/lighting contest was seconded by Dan Glotzbach and carried.

Clerk presented finance report. No action was taken.

Utility Superintendent Alan Zlatnik reported on damage to light pole and banner arm on street light at the library. Zlatnik noted that repairs would be paid for by contractor doing construction in area.

Superintendent Zlatnik reported on quote for netting around raised deck at Campbell field and fencing for bull pens and backstop. Zlatnik did not recommend proceeding with netting due to cost. Council discussed moving of deck to outfield. Following discussion, no action was taken.

Trish Heim inquired about trash bags at forestry dump and reported street light that was out.

Jeff Busch of Bush & Associates was present to provide information on camera reader system. Police Chief Jason Connell would like to have current camera system replaced and add additional cameras. Following presentation Busch to prepare price quote.

Council discussed possible code violations at 425 E. Pottawatomie. Chief Connell noted that condemning trailer may require health department involvement.

Council discussed dog breed specific ordinances. Following discussion, no action was taken.

Toby McCullough inquired about easement changes to property at 609 A Griswold Street. Clerk reported that fence permit was approved by Building Code Enforcement Officer Jeffrey Overmyer and that no other changes to easement was planned.

Clerk presented quote from Century Business Technologies for new copier/printer equipment and maintenance contracts at cost of \$194.37 per month. Following discussion motion by Christi McKenzie to approve proposal from Century Business Technologies for copiers was seconded by Trish Heim and carried.

Clerk presented request for donation to project prom for 2022. Motion by Dan Glotzbach to donate \$250.00 to project prom was seconded by Toby McCullough and carried.

Motion by Christi McKenzie to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 8:15pm.
