Motion by Dan Glotzbach to approve purchase and installation of auto dialer to be completed after January 1 was seconded by Todd Reeves and carried.

Superintendent Alan Zlatnik reported that Silver Lake was in the process of hiring for the position of Utility Supervisor and that some Rossville personnel may be interested.

Interim Police Chief Doug Schreiner presented report on potential asset forfeiture payments. No action was taken.

Interim Police Chief Doug Schreiner presented Police Department Report document. No action was taken.

Mayor reported on actions taken regarding property at 607 A Griswold Street. No action was taken.

Toby McCullough reported that he was working on getting information on plans for walking trail. Mayor noted that email from City Attorney Stanley Oyler was forwarded to Myron Leinwetter.

Clerk reported on cash amounts in asset forfeiture accounts.

Mayor James Meyer appointed Doug Schreiner as Assistance Chief of Police. Motion by Toby McCullough to approve appointment was seconded by Trish Heim and carried.

Motion by Toby McCullough to adjourn was seconded by Taylor Morelli and carried. Meeting adjourned at 7:17pm.
