Motion by Dan Glotzbach to pay bills as presented totaling \$50,816.20 was seconded by Todd Reeves and carried.

Motion by Trish Heim to approve agenda with addition of June Burgett, Helen Lytle and Sue Badura representing the Senior Citizen Center was seconded by Rick Towers and carried.

June Burgett, Helen Lytle and Sue Badura provided the council with information on the cost for renewal of the insurance coverage for the Senior Citizens Center and requested assistance from the City with some of the expense. Following discussion matter was tabled until next regular meeting to allow time to check on options for insurance coverage.

Mayor reported that the memorial bench for Kenneth Wichman had been install in front of City Hall.

Utility Superintendent Alan Zlatnik reported that the forestry dump is now open but residents will need to call City Hall to get gate lock code before taking items to the facility.

Superintendent Zlatnik reported that Howard Parr was complaining about work that was done at forestry dump. Council reviewed Shawnee County maps of property lines. No action was taken.

Superintendent Zlatnik also reported that excavator rented for this project was still being used for other projects and that during clean up at the water pump facility a vehicle hit a rock that they believe fell from the City truck onto roadway. Clerk noted incident report has been sent to insurance for claim processing.

Assistant Police Chief Douglas Schreiner reported on information obtained by Chief Sipp regarding pedestrian beacons; purchasing of new police vehicle; updating deer tags; investigation of incident occurring on school property; city code enforcement issues and additional ongoing and planned activities of the police department.

Jim Clancy arrived and requested permission to address council. Mr. Clancy of Pearl Real Estate reported he was representing the new owner of property at 423 Main Street in looking for medical provider as new tenant of building and inquired if council had any ideas or suggestions. Council provided suggestions.

Motion by Trish Heim to go into executive session for 20 minutes to discuss personnel was seconded by Dan Glotzbach and carried. Executive session to be from 7:03 to 7:23pm. Mayor and council to attend.

Council reconvened in open session at 7:27pm.

Ordinance AMENDING SECTION 12-305 OF THE CITY CODE OF ROSSVILLE REGARDING OVERNIGHT PARKING was presented. Motion by Todd Reeves to approve ordinance was seconded by Dan Glotzbach and carried. Ordinance was assigned number 850.

Request for adjustment of water bill at 425 E. Pottawatomie was presented. Motion by Todd Reeves to approve adjustment by half the overage was seconded by Rick Towers and carried.

Application for drinking establishment license for The Dawg House was presented. Clerk reported that fee/tax had been paid. Motion by Dan Glotzbach to approve license was seconded by Todd Reeves and carried.

Request for donation to Rossville High School project PROM was presented. Motion by Dan Glotzbach to donate \$250.00 was seconded by Vern Sumner and carried.

Council discussed dates and menu for City employee holiday dinner.

Motion by Trish Heim to adjourn was seconded by Todd Reeves and carried. Meeting adjourned at 7:50pm.
