Motion by Dan Glotzbach to pay bills as presented totaling \$38,288.29 was seconded by Trish Heim and carried.

Motion by Taylor Morelli to approve agenda as written was seconded by Dan Glotzbach and carried.

Morgan Hansen with Rossville Community Development Committee was present to request permission from council to close the 400 block of Main Street for Christmas Parade on Saturday, December 3 from 5 to 8:30 p.m. and to request donation from the City for lighting contest prize. Following discussion, motion by Toby McCullough to close Main Street for parade and donate \$300.00 for contest prize was seconded by Todd Reeves and carried.

Council had discussion regarding fitness court. Mayor reported that he had traveled to Meriden and viewed the fitness court. Following discussion, no action was taken.

Approval of Cereal Malt Beverage license was tabled until next meeting for background check.

Utility Superintendent Alan Zlatnik discussed use of frisbee golf course at City Park and advised that several poles need to be repaired.

Interim Police Chief Doug Schreiner reported on actions taken since retirement of Police Chief Jason Connell and provided council with 10-year capital plan and traffic enforcement data from October 31, 2021 to October 31, 2022. Following discussion of reports presented and capital projects needing to be completed in 2022 motion by Trish Heim to proceed with projects totaling \$19,900.00 was seconded by Toby McCullough and carried.

Toby McCullough reported that Brandon Bergstresser had invoiced the City for the construction of the new City limits sign at original quoted price and has donated the cost of overages of the construction. Clerk noted that there have been lots of positive comments on the new sign.

Council noted that motorhome with open connection to sewer in alley at 418 Main Street has been moved.

Code Enforcement Administrator Jeffrey Overmyer reported on property at 607A Griswold Street. Council reviewed ordinance and requested that City proceed with actions to declare the property unfit for human habitation.

Council reviewed request for change of easement at 644 Navarre. Following discussion, motion by Toby McCullough to approve change to easement was seconded by Taylor Morelli and carried.

Clerk reported that employees were requesting permission from council to have the day after Thanksgiving off as holiday. Following discussion, motion by Trish Heim to allow employees to trade Veterans Day Holiday for day after Thanksgiving was seconded by Todd Reeves and carried.

Water bill adjustment request for 120 W Highway 24 Trafficway due to leak was presented. Motion by Todd Reeves to approve adjustment by half the overage was seconded by Dan Glotzbach and carried.

Council discussed dates for City Christmas party. Mayor to check with Rossville American Legion on dates.

Motion by Trish Heim to go into executive session for 15 minutes to discuss legal issues was seconded by Todd Reeves and carried.

Council reconvened in open session at 8:28pm.

Motion by Todd Reeves to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 8:28pm.
