
## CITY of ROSSVILLE founded in 1871 "Come Grow With Us!"

The Rossville City Council meeting was called to order on Monday, October 19, 2020 at 7:00 pm by Mayor Kenneth Wichman using online Zoom meeting.

Council members present via Zoom were Trish Heim, Dan Glotzbach, Christi McKenzie and Toby McCullough. James Meyer was absent.

Motion by Dan Glotzbach to pay bills as presented totaling \$48,483.44 was seconded by Toby McCullough and carried.

Motion by Trish Heim to approve agenda as written was seconded by Dan Glotzbach and carried.

Morgan Hansen with Rossville Community Development Committee reported on scheduled activities for the Christmas Celebration on December 5, 2020 and requested permission to shut down street along Andrick Park from 4 to 8pm and hold tree lighting ceremony. Motion by Christi McKenzie to approve tree lighting in Andrick Park and to shut down street during event was seconded by Trish Heim and carried.

Kelli Kenney representing the Rossville High School Booster Club was present to request permission to hold a reverse parade for homecoming from 6:30 to 7:30 pm in the 400 block of Main Street. Motion by Trish Heim to allow reverse parade was seconded by Toby McCullough and carried.

Mayor reported on mock tornado event scheduled for October 28 and 29<sup>th</sup>. Police Chief Jason Connell was working with organizer to hold activities at Dekat Hall.

Mayor presented information and pictures taken of Thederahn property at 615 Maple Court. Council had discussion with Sherry Thederahn regarding completion of fence and sidewalk. Following discussion council agreed to extend time to have fence construction completed to December 1, 2020 and extend time to have sidewalk installed to July 1, 2021.

Jeffrey Overmyer arrived at 7:24pm.

Dan Glotzbach reported that he had noticed furniture along roads and alleys and "junk" cars and asked about sweeping town to notify owners in violation. Following discussion regarding Shawnee County Refuse picking up on large item per week and Items behind Millers Motors shop Chief Jason Connell reported that items would be addressed.

Utility Superintendent Alan Zlatnik reported that the Department of Labor had conducted a safety inspection of City facilities and only identified a couple of minor items.

Superintendent Zlatnik reported that Flint Hills Underground had failed to fill in some holes in town when putting in fiber optic lines but have been contacted and should take care of in the next couple weeks.

Council noted that park play area was looking great with three play structure roofs replaced.

Police Chief Jason Connell inquired about signs at park play area indicating ages to use equipment.

Chief Connell reported on vehicle stop that resulting in removal of drugs from street and arrest of driver.

Toby McCullough expressed concerns about quality of internet service in Rossville and inquired about any plans to get other providers. Trish Heim noted that the council had been in contact with WTC and that she would recontact them regarding any new information.

Motion by Dan Glotzbach to adjourn was seconded by Christi McKenzie and carried. Meeting adjourned at 7:44pm.
