Motion by Dan Glotzbach to pay bills as presented totaling \$35,553.18 was seconded by Rick Towers and carried.

Motion by Trish Heim to approve agenda with addition of Morgan Hansen was seconded by Todd Reeves and carried.

Morgan Hansen was present as Rossville Community Development Committee president to report on plans for the Christmas Festival scheduled for December 2, 2023 and to request permission to shut down Main Street for parade at 6:30pm. Hansen also requested \$300.00 donation for lighting contest prizes. Following discussion motion by Dan Glotzbach to donate \$300.00 to RCDC for lighting contest prize and approve closing of Main Street was seconded by Trish Heim and carried.

Morgan Hansen representing the Rossville Christian Church requested permission to use Main Street for Halloween Trunk n Treat on October 31, 2023. Following discussion council agreed to allow trunk n treat activities on Main Street and requested that closing down street be coordinated with businesses on Main Street.

Thomas Sipp arrived at 6:15pm.

Clerk presented application from S and S Stores LLC for cereal malt beverage license for sale in original and unopened containers. Clerk reported that background check had been completed and all fees paid. Motion by Dan Glotzbach to approved license for S and S Stores was seconded by Rick Towers and carried.

Utility Superintendent Alan Zlatnik recommended that council review policies for campers in City Park and consider raising camping fees.

Superintendent Zlatnik reported that Kansas Department of Health and Environment was ok with moving lagoon fence as long as not on berm to allow for new location of forestry dump. Council had discussion of proposed location for new forestry dump. No action was taken.

Superintendent Zlatnik reported that he was still getting prices for purchasing excavator.

Police Chief Thomas Sipp reported on gravel pile at end of cul-de-sac. Following discussion councilmembers Todd Reeves and Rick Towers volunteered to install guardrail to stop drive thru traffic.

Chief Sipp also reported on court action on code violations; lockdown drill at Rossville Grade School; car wash; highway 24 crosswalks; tree removal at 321 Navarre; increased police coverage; monitoring of stop sign at Parkway and Pearl; police personnel activities; Facebook post regarding trespassing and blanket registration for off road vehicles.

Council discussed Campbell Field advertising signs. Clerk reported that new signs would cost \$500.00 through Knox Signs. Following discussion council requested that City price canvas signs.

Council discussed past agreement with Kratina for excavator use.

Council had further discussion on tree removal at 321 Navarre and debris in floodway. Mayor to contact property owner.

Clerk requested permission to add Roth option to employees KPERS 457b plan. Motion by Trish Heim to allow adding Roth option was seconded by Dan Glotzbach and carried.

Motion by Rick Towers to adjourn was seconded by Trish Heim and carried. Meeting adjourned at 7:28pm.
