Ron Andrick representing the Rossville Christian Church was present to request permission to close a portion of the street in front of the church at 411 Spruce on October 9, 2021 from 4 to 7 pm during church fall festival. Following discussion motion by Toby McCullough to approve closing of street was seconded by Trish Heim and carried. City to provide barricades to block street.

Christi McKenzie reported that she had received several calls regarding the decision to not hold the Halloween hot dog/chili feed and wanted to revisit this decision. McKenzie inquired about looking at other ways to hold event. Following discussion motion by Christi McKenzie to hold hot dog feed in cooperation with the Shawnee County Fire District #3 and the Rossville Christian Church was seconded by Dan Glotzbach and carried.

Dan Glotzbach inquired about sidewalk across railroad tracks on Anderson Street crossing. Following discussion Glotzbach volunteered to write letter requesting the railroad consider putting in sidewalk for consideration at the next meeting.

Trish Heim reported that WTC would start transitioning some service to customers this week.

Utility Superintendent Alan Zlatnik reported that KDHE had conducted inspection at forestry dump and all was ok however Zlatnik reported that they would be closing dump and scheduling by appointment only as the bean crop in the area was dry and the city needed to monitor for fire danger. Notice to be put on Facebook and website regarding need to schedule appointment.

Superintendent Zlatnik reported that contract with McGuire Iron for painting of water tower had been signed and that they had purchased an ice machine for the City shop at cost of \$350.00.

Christi McKenzie inquired about handicapped parking stalls along Main Street for library patrons now that new entrance will be handicapped accessible. Clerk noted that ordinance would be needed.

Police Officer Trent Stanley reported for Chief Jason Connell. Council inquired about shifts and confirmed scheduling for Halloween.

Christi McKenzie inquired about winterizing at pool. Clerk to contact Shawnee County Parks and Recreation and confirm that winterizing has been completed and electric service can be shut off.

Mayor reported that after receiving letter regarding remaining building floodproofing and elevation certificates needed to complete qualification in the FEMA CRS program he had contacted State NFIC Coordinator Steve Samuelson and was waiting for reply.

Clerk reported that she had not received a reply on inquires about Cross Creek Homeowners Association.

Council had discussion regarding the courts closing of code enforcement cases that were on the agenda at the last court session.

Motion by Toby McCullough to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 7:43pm
