Council discussed gravel ramp off of the cul-de-sac in the 500 block of Main Street.

Police Chief Thomas Sipp reviewed police department report detailing activity and actions taken by the department including plans for homecoming parade, football games and abatement notice at 615 Green Street as well as discussion of school zones and school crossings.

Utility Superintendent reported that they should be setting the poles for the lighting at Campbell Field in a couple weeks and that he had ordered signs for the Park.

Council discussed costs for renewal of dog pound license. Following discussion motion by Vern Sumner to renew pound license was seconded by Dan Glotzbach and carried.

Council inquired about status of fire damaged structure at 402 Main Street. No information was available. Council requested that Jeffrey Overmyer contact owner regarding status.

Proposed 2024 budget was presented for approval. Motion by Dan Glotzbach to approve 2024 budget was seconded by Trish Heim and carried.

Moton by Rick Towers to adopt Resolution 23-08-05 resolving that the City of Rossville shall levy a property tax rate exceeding the Revenue Neutral Rate of 44.258 mills was seconded by Vernon Sumner and carried.

Application for demolition permit for shed at 617 Pearl Street was presented. Motion by Dan Glotzbach to approve permit was seconded by Trish Heim and carried.

Council discussed advertising signs at Campbell Field. Following discussion council requested that signs in need of repair or for closed/changed businesses be removed and application for new signs would need to be submitted.

Motion by Dan Glotzbach to adjourn was seconded by Rick Towers and carried. Meeting adjourned at 7:13pm.
