Mayor presented letter of apology for ruckus during hog ball tournament.

Police Chief Jason Connell requested executive session to discuss personnel.

Police Officer Harry Hammer III reported on costs for upgraded crossing lights on Highway 24 and contact with KDOT regarding traffic study.
