

Mayor reported on emails between City Attorney Stanley Oyler and Myron Leinwetter regarding walking trails and expressed concerns regarding terms of lease. Following discussion council agreed to have City Attorney continue work on lease agreement with proposed changes.

Council discussed postponing Christmas dinner. Following discussion council agreed to postpone dinner until Wednesday, December 29, 2021.

Council noted that the utility department did great job decorating parks for the holidays.

Clerk reported that League of Kansas Municipalities had reviewed City pit bull dog ordinance. No action was taken.

Council had discussion regarding sidewalks in need of repairs. No action was taken.
