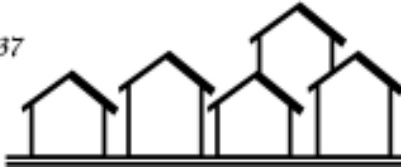

Due to the holiday on Monday the Rossville City Council meeting was called to order on Tuesday, February 18, 2025 at 6:00 pm by Mayor James Meyer.

Council members present were Trish Heim, Vern Sumner, Dan Glotzbach and Rick Towers. Todd Reeves was absent.

Also present were Thomas Sipp and Alan Zlatnik.

Motion by Rick Towers to approve the minutes of the February 3, 2025 meeting as corrected was seconded by Trish Heim and carried.

Motion by Dan Glotzbach to pay bills as presented totaling \$50,600.44 was seconded by Vern Sumner and carried.

Motion by Trish Heim to approve the agenda as presented was seconded by Rick Towers and carried.

Mayor James Meyer appointed Jenna Stum, Chance Stum, Taylor Morelli, Kristen Henry, Scott Graves and Justin Martinez as members of the Rossville Community Recreation Association. Motion by Dan Glotzbach to approve appointments was seconded by Trish Heim and carried.

Mayor reported that the Shawnee County Historical Society would like to have someone do a presentation on March 9th or 16th on the historical ball stadium. Following discussion Mayor and Rick Towers to look at options and work on a presentation.

Utility Superintendent Alan Zlatnik discussed snow removal issues and noted that Shawnee County would not be hauling off snow this week. Superintendent Zlatnik also reported on asphalt damaged by private snow removal businesses. No action was taken at this time.

Council inquired about the yellow box blade that is on the tractor. Superintendent report that this is a snow box that belongs to Chance Stum that they wanted to try on the City streets. Council thanked Zlatnik and his crew for their hard work during the snow storms.

Police Chief Thomas Sipp reported that J. Warren was out last week and installed the new crosswalk signs and signals; that all equipment has been received from Axon for installing the cameras into the patrol vehicles; that contractor will be painting the crosswalks, stop lines and other street lines on Highway 24 when weather allows; that he and Brooklyn are submitting past Federal Forfeiture reports to become compliant as well as Use of Force and Accident reports. In addition, Chief Sipp noted that the law enforcement and court agreements have been forwarded to the City of Willard.

Chief Sipp presented incident report for January, 2025.

Mayor reported on plans for repairs to the ball field grandstand. No action was taken.

Request for adjustment to water bill at 607 B Griswold Street due to leak was presented. Motion by Dan Glotzbach to approve adjustment by half the overage was seconded by Vernon Sumner and carried.

Request to make changes to easement by removing gravel and planting grass at 528 Pine Street was presented. Motion by Rick Towers to approve changes was seconded by Trish Heim and carried.

Motion by Trish Heim to adjourn was seconded by Vernon Sumner and carried. Meeting adjourned at 6:57pm.
