

Mayor appointed Stanley Oyler as City Attorney. Motion by James Meyer to approve appointment was seconded by Travis VanVleck and carried.

Mayor appointed Alan Streit as Municipal Court Judge. Motion by Travis VanVleck to approve appointment was seconded by Trish Heim and carried.

Mayor appointed Lisa Stum as City Clerk. Motion by James Meyer to approve appointment was seconded by Christi McKenzie and carried.

Mayor appointed Tracey Taylor as Asst. City Clerk. Motion by Christi McKenzie to approve appointment was seconded by Travis VanVleck and carried.

Mayor appointed Christi McKenzie as Commissioner of Parks. Motion by Travis VanVleck to approve appointment was seconded by James Meyer and carried.

Mayor appointed Travis VanVleck as Commissioner of Streets. Motion by Christi McKenzie to approve appointment was seconded by Dan Glotzbach and carried.

Mayor appointed James Meyer as Commissioner of Water/Sewer. Motion by Christi McKenzie to approve appointment was seconded by Travis VanVleck and carried.

Mayor appointed Trish Heim as Commissioner of Ordinances. Motion by Travis VanVleck to approve appointment was seconded by James Meyer and carried.

Mayor appointed Dan Glotzbach as Commissioner of Finance. Motion by Christi McKenzie to approve appointment was seconded by Trish Heim and carried.

Motion by Christi McKenzie to elect James Meyer as council president was seconded by Trish Heim and carried.

Council acting as the Kross Subdivision #3 Architectural Control Committee reviewed request from resident of 625 Redwood Drive for approval for plans to place shed on property. Following discussion and review of plans motion by Travis VanVleck to approve was seconded by Dan Glotzbach and carried. Resident must continue with approval of building permit application.

Mayor presented copy of letter expressing the City of Rossville's support of the request by the Moravan Lodge #128 to have "The Polka" recognized as the official State Dance of Kansas.

Utility Superintendent Alan Zlatnik was asked about getting City park play area ready for 10-year anniversary celebration. Following discussion Zlatnik to get prices on mulch.

Police Chief Jason Connell presented application from Jacob Akin for part time police officer and recommended that the City hire Akin. Motion by Travis VanVleck to approve hiring at \$15.00 per hour was seconded by James Meyer and carried.

Mayor presented revised information on refinancing of existing GO bonds and issuance of new bonds. Following discussion motion by Christi McKenzie to approve refinance and new bonds in the amount of \$291,000.00 at a 3% interest rate for a term of 10 years was seconded by James Meyer and carried.

Alan Zlatnik reported that there was no new information on the pool repairs.

Council noted that there are limbs down along Orange Street that may pose safety hazard. Police Chief Jason Connell reported that he would check. Chief Connell noted several properties that he was working on code compliance issues.

Motion by Travis VanVleck to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 7:34pm.
