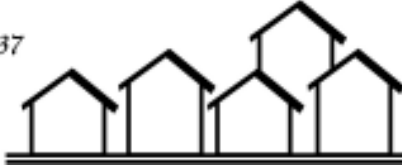

Motion by Toby McCullough to pay bills as presented totaling \$71,582.05 was seconded by Dan Glotzbach and carried.

Motion by Dan Glotzbach to approve agenda as written was seconded by Trish Heim and carried.

Mark Campbell was present to talk to council about getting approval to construct storage units on property he has purchased at 601 E Highway 24 Trafficway. Following discussion council requested that Campbell report back to council with more information.

Mayor James Meyer appointed Stanley Oyler as City Attorney. Motion by Trish Heim to approve appointment was seconded by Dan Glotzbach and carried.

Mayor James Meyer appointed Alan Streit as Municipal Court Judge. Motion by Toby McCullough to approve appointment was seconded by Christi McKenzie and carried.

Mayor James Meyer appointed Lisa Stum as City Clerk. Motion by Christi McKenzie to approve appointment was seconded by Trish Heim and carried.

Mayor James Meyer appointed Jason Connell as Police Chief. Motion by Trish Heim to approve appointment was seconded by Dan Glotzbach and carried.

Mayor James Meyer appointed Alan Zlatnik as Utility Superintendent. Motion by Christi McKenzie to approve appointment was seconded by Trish Heim and carried.

Mayor James Meyer appointed Tami Eustice as City Treasurer. Motion by Dan Glotzbach to approve appointment was seconded by Toby McCullough and carried.

Mayor James Meyer appointed council member Christi McKenzie as Park Commissioner. Motion by Dan Glotzbach to approve appointment was seconded by Trish Heim and carried.

Mayor James Meyer appointed council member Toby McCullough at Street Commissioner. Motion by Christi McKenzie to approve appointment was seconded by Trish Heim and carried.

Mayor James Meyer appointed council member Trish Heim as Ordinance Commissioner. Motion by Christi McKenzie to approve appointment was seconded by Dan Glotzbach and carried.

Mayor James Meyer appointed council member Todd Reeves as Water and Sewer Commissioner. Motion by Toby McCullough to approve appointment was seconded by Christi McKenzie and carried.

Mayor James Meyer appointed council member Dan Glotzbach as Finance Commissioner. Motion by Trish Heim to approve appointment was seconded by Toby McCullough and carried.

Motion by Toby McCullough to elect Trish Heim as Council President was seconded by Christi McKenzie and carried.

Mayor James Meyer appointed the Metro News/Shawnee County Ledger as the City Official Newspaper. Motion by Toby McCullough to approve appointment was seconded by Dan Glotzbach and carried.

Utility Superintendent Alan Zlatnik reported that Kansas Department of Health and Environment had notified the City that two of the wastewater samples tested as part of the quarterly testing requirement had exceeded the City permit limits. The contractor that previously had taken samples was no longer in business so samples have been taken by City personnel. Zlatnik reported that he had contacted Kansas Rural Water Association for assistance in determining the cause of the permit exceedances and was able to determine several contributing factors including the location that samples were being taken from and use of separate dipper for influent sample and effluent sample. New sample was submitted and analyses shows results are back to normal and no longer exceeding limits.

Utility Superintendent Alan Zlatnik reported that after burning brush at forestry dump embers ignited corn stubble in field near the burn area. The area was inspected by KDHE personnel and no issues were found. Owner of property burned has filed an insurance claim.

Utility Superintendent Alan Zlatnik reported on bids for repairs and upgrades to lighting at Campbell Stadium and noted that insurance had paid for damages caused by wind storm to fence and pole. Following discussion and review motion by Christi McKenzie to accept bid not to exceed \$48,000.00 to replace three poles at Campbell Stadium with LED light fixtures using general fund money previously budgeted to transfer to special street was seconded by Toby McCullough and carried.

Council requested that Superintendent Alan Zlatnik look at getting sign along drainage ditch repaired.

Police Chief Jason Connell reported on progress with inspection of trailer at 525 W. Pottawatomie Street.

Chief Jason Connell reported that he was still working on quote for cameras.

Chief Jason Connell reported that pit bull dogs at property on Pearl Street had been removed but vehicles still needs to be moved.

Council had no information on City limit sign.

Council to address sidewalk across Railroad property at Anderson Street crossing in spring.

No new information has been received regarding repairs to drainage ditch.

Motion by Toby McCullough to adjourn was seconded by Trish Heim and carried. Meeting adjourned at 7:58pm.
