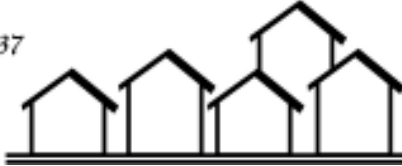

January 3, 2022

The Rossville City Council meeting was called to order on Monday, January 3, 2022 at 7:00 pm by Mayor Kenneth Wichman.

Council members present were Dan Glotzbach, Trish Heim, James Meyer, Christi McKenzie and Toby McCullough.

Also present was Alan Zlatnik and Jason Connell

Motion by Christi McKenzie to approve minutes of the December 20, 2021 meeting as written was seconded by Trish Heim and carried.

Motion by Dan Glotzbach to approve minutes of the December 29, 2021 special meeting as written was seconded by Christi McKenzie and carried.

Motion by Christi McKenzie to pay bills as presented totaling \$5,836.70 was seconded by Dan Glotzbach and carried.

Motion by Trish Heim to approve agenda as written was seconded by James Meyer and carried.

Mayor reported on emails regarding proposed walking trails and lease agreements. No action was taken.

Toby McCullough inquired about progress of welcome sign at South entrance. Mayor reported that stone not completed yet.

Christi McKenzie reported US Bank had donated the pictures from the Rossville facility to the Rossville Community Library.

Utility Superintendent Alan Zlatnik reported on cost estimates for repairs to Campbell Stadium and light pole on Main Street damaged in wind storm event. Council discussed possible upgrades to stadium lights and putting netting in place of chain link. No action was taken.

Police Chief Jason Connell reported that inspection was scheduled for property at 425 E. Pottawatomie.

Chief Connell reported that Officer Schreiner would be handling scheduling of part time police officers to cover Officer Dick's shifts.

Chief Connell reported that pit bull dog puppies had been removed from the City and that he would be checking on report of pit bull dog residing in City limits.

Chief Connell reported that the New Years holiday was uneventful.

Mayor reported that the City insurance carrier Berkshire Hathaway had notified the City they would not be renewing the City worker compensation insurance. Clerk has contacted KMIT about workers compensation insurance and provided information to council regarding KMIT. Council had discussion regarding quotes for blanket insurance coverage. Following discussion council instructed clerk to request bids.

Motion by Toby McCullough to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 7:37pm.
