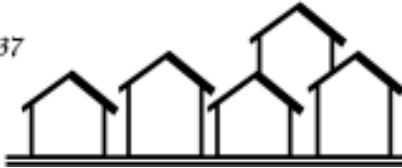

January 3, 2023

Due to the holiday on Monday the Rossville City Council meeting was called to order on Tuesday, January 3, 2023 at 5:59 pm by Mayor James Meyer.

Council members present were Todd Reeves, Trish Heim, Toby McCullough, Dan Glotzbach and Taylor Morelli.

Also present were Bill Sutton, Doug Schreiner, Alan Zlatnik and Jim Dodge.

Motion by Toby McCullough to approve minutes of the December 19, 2022 meeting as corrected was seconded by Todd Reeves and carried.

Motion by Toby McCullough to approve minutes of the December 27, 2022 special meeting as written was seconded by Todd Reeves and carried.

Motion by Dan Glotzbach to pay bills as presented totaling \$38,721.56 was seconded by Trish Heim and carried.

Bill Sutton, Director of Shawnee County Solid Waste was present to notify council that recycling containers that were located at Wehner's Thriftway have been removed and will be replaced with a cardboard only container with glass recycling remaining in place. In addition, starting February 1, 2023 Shawnee County will implement an addition \$3.50 fee for recycling totes and \$5.00 for each extra tote. Customers will have choice to continue recycling at addition cost of \$3.50 or opt out of recycling. Following discussion Mayor noted that City may need new contract with Shawnee County Solid Waste.

Jim Dodge was present to express concerns about how increase in solid waste and recycling services would impact retired person with fixed income and urged commissioners to look at ways to continue service without increasing cost.

Utility Superintendent Alan Zlatnik reported that recent cold weather resulted in three residents reporting water leaks and reported that no salt/sand was put on streets. Superintendent Zlatnik also recognized Brad Kirk and Randy Anderson for going out in below 30 temps to work while still smiling.

Assistance Police Chief Doug Schreiner reviewed 2022 annual report of incidents and council items. Council inquired about invoice for dress uniform. Schreiner noted that this was purchased by Jason Connell for trip to Washington for fallen officer's memorial honoring fallen officer Kerry Dick.

Mayor reported that Code Enforcement Officer Jeffrey Overmyer still had not been contacted by property owner at 607A Griswold Street regarding condition of structure and that hearing is still scheduled for February 21, 2023 at 6:00pm.

Motion by Dan Glotzbach to go into executive session for 15 minutes to discuss personnel was seconded by Todd Reeves and carried. Executive session to be from 6:45 to 7:00 pm with Mayor and council attending.

Council reconvened in open session at 7:03pm

Clerk inquired about mailing notices to customers regarding changes to solid waste. Council approved.

Mayor reported that Union Pacific Railroad had been contacted regarding condition of crossings in Rossville and hopefully they will address the issue.

Motion by Taylor Morelli to adjourn was seconded by Trish Heim and carried. Meeting adjourned at 7:07pm.
