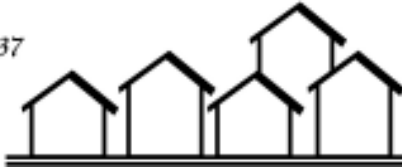

The Rossville City Council meeting was called to order on Monday, January 4, 2021 at 7:01 pm by Mayor Kenneth Wichman using online Zoom meeting.

Council members present via Zoom were Trish Heim, Dan Glotzbach, Christi McKenzie, James Meyer and Toby McCullough.

Motion by Dan Glotzbach to pay bills as presented totaling \$3,385.35 was seconded by Christi McKenzie and carried.

Motion by James Meyer to approve agenda as written was seconded by Toby McCullough and carried.

Mayor reported that he had approved payment to part time utility employee Randy Anderson for time worked on holiday doing snow removal be paid at 1 and ½ time and thanked employees for working on holiday to remove snow.

Utility Superintendent reported that the new snow plow worked well.

Mayor reminded governing body that items to be put on the agenda can be completed by contacting clerk's office before 12 noon on the Friday before the scheduled meeting.

Trish Heim inquired about City website. Assistance Clerk Tracey Taylor reported that she would be working on website and have updates by the end of the month.

Asst. Clerk Tracey Taylor also reported that she was still a member of the Senior Center board. Renovation to the center look great.

Jason Connell joined meeting at 7:15pm.

Police Chief Jason Connell reported that plans were being put in place to provide COVID vaccinations for first responders and inquired as to if the shots would be voluntary or mandatory. Following discussion council noted shots would not be mandatory, however first responders should be educated on the vaccinations and encouraged to consult with their primary health care providers regarding the vaccine. Council also requested that the City consult with the League of Municipalities regarding any federal or state requirements for COVID vaccinations.

Council had discussion regarding trash/junk in yards. Chief Connell reported that his department would be addressing next week or so.

Motion by Trish Heim to adjourn was seconded by Toby McCullough and carried. Meeting adjourned at 7:26pm.
