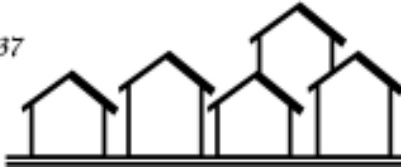

January 6, 2025

The Rossville City Council meeting was called to order on Monday, January 6, 2025 at 6:00 pm by Mayor James Meyer.

Motion by Dan Glotzbach to pay bills as presented totaling \$36,556.01 was seconded by Trish Heim and carried.

Motion by Trish Heim to approve the agenda as presented was seconded by Vern Sumner and carried.

Mayor reported that Kansas Department of Wildlife and Parks had notified that City that the grant application submitted through the LWCF program was not selected for funding. Myron Leinwetter to consult with council on ways to proceed with possible funding.

Utility Superintendent Alan Zlatnik reported on snow removal. Council thanked the utility department for hard work plowing snow.

Council reported to Zlatnik that there had been some discolored water. Zlatnik to check but reported that hydrants had been flushed twice.

Police Chief Thomas Sipp reported that the police department has been spending funds left at end of year to upgrade electrical service at the police station as well as an electronic door release.

Chief Sipp reported that ATV/UTV registration renewal notices had been mailed; that the utility department had made repairs to storage structure at police department to allow for parking of patrol vehicles out of the weather; that Brooklyn had submitted accident reports noting that reports have not been submitted since 2017; Axon training has been rescheduled due to weather; plans to talk to part-time officers at staff meeting regarding working regular hours; conversation with KBI regarding monthly reports that need to be submitted and replacement of lights in the police station.

Council discussed additional security/road blocks for community events such as car shows and parades. Chief Sipp to look at any additional measures that may be taken.

Request for changes to easement at 644 Navarre was presented. Following discussion with Superintendent Zlatnik motion by Dan Glotzbach to approve request was seconded by Rick Towers and carried.

Application for drinking establishment from the Dawg House was presented. Motion by Dan Glotzbach to approve the Dawg House as a drinking establishment was seconded by Rick Towers and carried.

Motion by Dan Glotzbach to adjourn was seconded by Trish Heim and carried. Meeting adjourned at 6:18pm.
