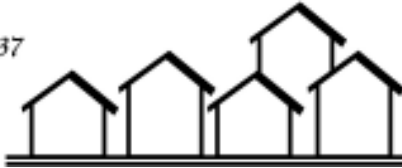

July 6, 2020

The Rossville City Council meeting was called to order on Monday, July 6, 2020 at 7:00 pm by Mayor Kenneth Wichman.

Motion by Trish Heim to pay bills as presented totaling \$37,403.06 was seconded by Dan Glotzbach and carried.

Motion by Christi McKenzie to approve agenda with the addition of Randy Dick, was seconded by Trish Heim and carried.

Randy Dick wanted to place a dumpster in front of his new building on Main Street. He requested permission to put the dumpster in the street in front of the building from Friday until Tuesday. Travis VanVelck moved to give permission with a second by Dan Glotzbach, motion carried.

Kristen Simpson was present to ask for permission to plant a tree in the city park with some of her mom's ashes buried under the tree. More information will be presented at the next council meeting.

Council Report – Christi McKenzie talked with Tim at Shawnee County Parks and Recreation. The County Commissioners have given approval to fix the newly found leak at the pool.

Utility Superintendent Alan Zlatnik reported that he had checked into mulch for the playground. By going with Topeka Forestry, they could get 1cu yd at \$33.50 per yard. That would be a total of \$3,350.00 with a \$100.00 delivery charge. Christi McKenzie moved to get the mulch with a second by Trish Heim. Motion carried.

Police Chief Jason Connell reported on theft of a catalytic converter here in town.

The Council discussed the Tall Corn Festival. It was decided that they would back the decision made by the Rossville Community Development Committee regarding whether to have the festival or not.

Christi McKenzie reported that the Rossville Community Foundation would give \$2,000 to the study for new bathrooms in the park. Travis VanVleck moved with a second by Dan Glotzbach to have BG Consultants start the study.

Mayor reported that Chad Shafstall had resigned from the Solid Waste Management Committee. Council will come up with some names that would be willing to serve on the committee.

The 2021 budget was reviewed. It was tabled to the next Council Meeting.

Council went into Executive Session at 7:51 p.m. for 15 minutes. Council Meeting resumed at 8:06.

Travis VanVleck moved to give the following raises back dated to June 1. Lisa, Alan, Brad, Jason, Trent at \$.50 an hour. Tracey at \$1.00 an hour. Trish Heim seconded, motion carried.

Motion by Dan Glotzbach to adjourn was seconded by Trish Heim and carried. Meeting adjourned at 8:12 pm.
