Brad Kirk reported for the utility department. Water tower is full. Samples are being taken and sent to KDHE for testing. Tower should be back in use later this week.

Chief Jason Connell reported that code enforcement will be starting soon.

Council went into executive session at 6:42 pm for 30 minutes, 7:12 pm, for salary discussions.

Salary review was tabled until next council meeting.

Refund of fireworks stand permit was tabled until next council meeting.

Toby McCullough moved to accept the drinking establishment license for Fastdraws with a second by Todd Reeves. Motion carried.

Water bill adjustment was requested for 312 Navarre St. Toby McCullough moved to adjust the water bill. Trish Heim seconded. Motion carried.
