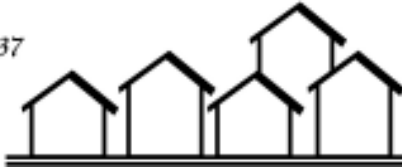

The Rossville City Council meeting was called to order on Monday, March 18, 2024 at 6:00 pm by Mayor James Meyer.

Motion by Dan Glotzbach to pay bills as presented totaling \$34,139.57 was seconded by Rick Towers and carried.

Motion by Trish Heim to approve agenda with the addition of Terry Kaufman was seconded by Dan Glotzbach and carried.

Terry Kaufman was present to provide the City Council with information on recent actions by the Shawnee County Planning Commission regarding wind and solar farms. No action was taken.

Mayor reported that the City was receiving quotes for employee health insurance.

Utility Superintendent Alan Zlatnik reported on tornado damage to roof of water pump house, problems with water meter at 123 Adrian after water was turned off/on by unauthorized individual and safety inspection conducted by the Kansas Department of Labor.

Superintendent Zlatnik reported that the fire department had been called to put out fire at forestry dump over the weekend and requested guidance from council regarding burning at dump.

Superintendent Zlatnik confirmed that debris piled along Toadstrangler Trail had been removed.

Police Chief Thomas Sipp reported on response from KDOT regarding updating of crosswalks on Highway 24, new camera system at the police station, response during and after tornado and request for additional street light.

Council had discussion regarding structure damaged by fire at 416 Navarre. Mayor to consult with City Attorney.

Mayor reported on meeting scheduled to discuss tornado sirens.

Mayor noted that Planning Commission meeting scheduled for 5:00pm had not been held as application for zoning change at 321 Navarre had been withdrawn.

Council discussed email from Midwest Coating regarding roof repairs at City Hall. Council approved proceeding with repairs with estimated cost of \$700.00.

Utility superintendent Alan Zlatnik reported that Shawnee County brought out drone to check water storage tower for any damage after tornado.

Motion by Todd Reeves to adjourn was seconded by Rick Towers and carried. Meeting adjourned at 6:55pm.
