

The Rossville City Council meeting was called to order on Monday, May 16, 2022 at 6:00 pm by Mayor James Meyer.

Council members present were Dan Glotzbach, Trish Heim and Toby McCullough. Todd Reeves was absent.

Motion by Dan Glotzbach to pay bills as presented totaling \$51,681.43 was seconded by Trish Heim and carried.

Motion by Trish Heim to approve agenda as written was seconded by Dan Glotzbach and carried.

Utility Superintendent Alan Zlatnik reported that KDHE had rescinded boil water advisory at 10am on Saturday but notification to him was not made until later in the day. Zlatnik also thanked Mayor for assisting with overnight repair of leak.

Council had discussion regarding plans for upgrades to infrastructure given the recent problems the City has had with water breaks. Superintendent Zlatnik reported that water pressure was up from 55 lbs. to 65 lbs. while running on pump and not storage tank during painting of tank that may have contributed to line breaks. Zlatnik noted that water storage tank initial coating of inside has been completed and final coat will need to cure for a week as they begin power washing the outside of the tank.

Council inquired about hiring part time summer help for the utility department. Superintendent Zlatnik reported that at this time he did not see need for summer help.

Mayor reported that carpet at city hall was to be cleaned and disinfected tomorrow.

Clerk requested permission to attend budget workshop on Wednesday at a cost of \$75.00. Motion by Trish Heim to allow clerk to attend workshop was seconded by Toby McCullough and carried.

Trish Heim inquired about work on code violations. Mayor reported that code violations was on list of items that he was addressing.

Matter of employee salary review was tabled until next meeting.

Clerk presented application from Garrett's Worldwide Enterprises, LLC on behalf of American Legion Post #31 to operate fireworks stand in the City of Rossville. Council had discussion of fee charged for permit. Following discussion motion by Dan Glotzbach to approve permit was seconded by Trish Heim and carried. Council to consider refund of fee to American Legion Post #31 for permit.

Council had discussion of tree's needing to be cut or removed on empty lots. No action was taken.

Council had discussion on proposed use of property next to Wehner's Thriftway and construction timeline. No action was taken.

Motion by Trish Heim to adjourn was seconded by Dan Glotzbach and carried. Meeting adjourned at 6:49pm.
