Due to the holiday on Monday the Rossville City Council meeting was called to order on Tuesday, September 8, 2020 at 7:01 pm by Mayor Kenneth Wichman using online Zoom meeting.

Council members present via Zoom were Trish Heim, Dan Glotzbach, Christi McKenzie and Travis VanVleck. James Meyer was absent.

Also present via Zoom were Alan Zlatnik, Tracey Taylor, Brad Kirk, Gary Spring and Jason Connell.

Motion by Christi McKenzie to approve minutes of the August 17, 2020 meeting as written was seconded by Dan Glotzbach and carried.

Motion by Travis VanVleck to pay bills as presented totaling \$194,667.05 was seconded by Christi McKenzie and carried.

Motion by Christi McKenzie to approve agenda as written was seconded by Trish Heim and carried.

Mayor Wichman reported that Beyond Baseball was having Campbell baseball field looked at for possible grass infield and irrigation. Wichman noted that Beyond Baseball would need to get written approval from the Governing Body to make those changes to the baseball field.

Christi McKenzie noted that the Moravian Lodge had presented artwork to the City showing the Victor School and Bohemian Hall historical area.

Utility Superintendent Alan Zlatnik presented bid from Bettis Asphalt to complete street overlay projects in Rossville at a cost of \$54,716.00. Zlatnik noted that he had requested bid from Hamm Asphalt but had not received yet. Following discussion motion by Travis VanVleck to accept bid from Bettis Asphalt for street overlay projects was seconded by Christi McKenzie and carried.

Utility Superintendent Alan Zlatnik presented contract proposal from Mayer Specialty Service, LLC and Rooterman for sewer cleaning services. Following discussion motion by Travis VanVleck to proceed with three-year contract with Rooterman for sewer cleaning services was seconded by Dan Glotzbach and carried.

Utility Employee Brad Kirk reported that work was continuing at the City park play area to replace broken and rotten lumber and distributing additional load of mulch that has been delivered. Council noted that the substance on the slide describe by some as "pizza" was in fact putty to fill in and repair damaged area. Council also discussed repairs and paint need to Campbell stadium and Kirk noted that weeds growing in infield had been addressed.

Police Chief Jason Connell reported on incidents that occurred over the weekend and reported on part time police officer's status. Council discussed issues with older kids on City park playground equipment and trash being left in park.

Mayor presented letter of resignation as City Council member from Travis VanVleck. Motion by Christi McKenzie to accept letter of resignation from Travis VanVleck was seconded by Trish Heim. Council expressed great appreciation to Travis VanVleck for the 11 years of service to the community as councilmember.

Mayor reported that he had received two qualified applicants to fill Travis VanVleck's City Council position. Following discussion Mayor Kenneth Wichman appointed Toby McCullough to fill this position starting at the next

regular scheduled meeting on September 21, 2020. Motion by Trish Heim to approve appointment was seconded by Dan Glotzbach and carried.

Mayor reported that after consulting with staff and employees the City was going to opt out of participation in the social security deferral.

Mayor reported that the US Bank branch in Rossville was going to be closed temporarily. US Bank has presented some options to the City for making deposits without having to transport to Topeka branch. Other option would be for the City to change accounts to the local Bank of the Flint Hills bank. Following discussion Mayor noted the City would try the options presented by US Bank and if not successful or US Bank closes permanently the City would look at moving accounts.

Motion by Christi McKenzie to adopt ordinance was seconded by Trish Heim and carried. Ordinance was assigned number 829.

Ordinance REGULATING PUBLIC OFFENSES WITHIN THE CORPORATE LIMITS OF THE CITY OF ROSSVILLE, KANSAS; INCORPORATING BY REFERENCE THE "UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES,"36th EDITION, AND REPEALING ORDINANCE # 824 was presented. Motion by Trish Heim to adopt ordinance was seconded by Christi McKenzie and carried. Ordinance was assigned number 830.

Motion by Dan Glotzbach to adjourn was seconded by Christi McKenzie and carried. Meeting adjourned at 7:39pm
