September 19, 2022

The Rossville City Council meeting was called to order on Monday, September 19, 2022 at 6:00 pm by Mayor James Meyer.

Council members present were Todd Reeves, Trish Heim, Toby McCullough, Dan Glotzbach and Taylor Morelli.

Also present was Alan Zlatnik.

Motion by Toby McCullough to approve minutes of the September 6, 2022 meeting as corrected was seconded by Taylor Morelli and carried.

Jason Connell arrived at 6:05 pm.

Motion by Dan Glotzbach to pay bills as presented totaling \$35,118.11 was seconded by Todd Reeves and carried.

Motion by Trish Heim to approve agenda as written was seconded by Toby McCullough and carried.

Mayor reported on ideas to use memorial contributions from family of former Mayor Kenneth Wichman. Council liked idea of bench in front of City Hall.

Utility Superintendent Alan Zlatnik reported that, after using pump full time while water standpipe was painted, the pump is needing to be replaced and well is being cleaned. Zlatnik suggested that general fund money budgeted for street repairs be used for pump replacement. Following discussion council agreed to reallocate funds for water pump.

Utility Superintendent Alan Zlatnik showed council the water meter lid with attached antenna and explained how antenna was attached to meter. Zlatnik reported that they have lost 20-25 meter antennas since they were installed at a cost of \$30-\$40 per antenna.

Utility Superintendent Alan Zlatnik reported that they had mowed ditch along East Perry Street.

Police Chief Jason Connell reported that the police department has increased presence along Main Street and that several citations have been issued.

Chief Connell reported that he was waiting on WTC for information regarding cameras and video storage and reported on camper along alley. Council reported problems with weeds along alley at 515 Pine and asked Chief Connell to check.

Council discussed problems with meter lids and antennas being damaged by customers. Council reviewed draft of notice to customers making them aware of the problem to be put on City website and Facebook page. Council also reviewed draft of Ordinance requiring customers to pay for damage. Clerk to check with City Attorney about putting charges for damage to meters or antennas on water bills.

Todd Reeves volunteered to serve as member of the Shawnee County Fire District #3 fire board. Mayor James Meyer appointed Todd Reeves to serve on fire board. Motion by Toby McCullough to approve appointment was seconded by Taylor Morelli and carried.

Council discussed Halloween hot dog feed. Following discussion matter was tabled for time to check with fire department about sponsoring.

Council discussed condition of railroad crossings. Chief Connell reported that he had no contact information for repairs to crossings and suggested that the City contact City Attorney.

Resolution declaring that in 2022 the Governing Body shall cause the financial statements and financial reports of the City of Rossville to be prepared on the basis of cash receipts and disbursements as adjusted to show compliance with the cash basis and budget laws of this State was presented. Motion by Dan Glotzbach to adopt resolution 22-09-19 was seconded by Todd Reeves and carried.

Council discussed posting of job opening for police chief position and presented draft of posting notice for approval. Council reviewed and approved posting. Mayor, Council Member Toby McCullough and Council Member Trish Heim to be members of hiring committee.

Trish Heim reported that Shawnee County Waste Management Committee would be meeting on October 18<sup>th</sup>.

Motion by Todd Reeves to adjourn was seconded by Taylor Morelli and carried. Meeting adjourned at 7:16 pm.
