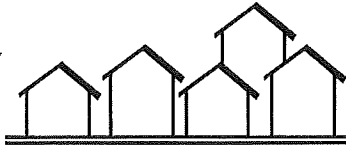

ORDINANCE NO. 872

AN ORDINANCE ADOPTING AND ENACTING A NEW CODE FOR THE CITY OF ROSSVILLE; PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES NOT INCLUDED THEREIN; PROVIDING A PENALTY FOR THE VIOLATION THEREOF; AND PROVIDING FOR THE MANNER OF AMENDING SUCH CODE;

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ROSSVILLE, KANSAS :

Section 1. The Code entitled "Code of the City of Rossville, Kansas, 2026" published by CivicPlus, LLC, is adopted and hereby incorporated by reference with no fewer than three copies marked or stamped "Official Copy as Adopted by Ordinance No. 872," and shall be filed with the City Clerk to be open for inspection and available to the public at all reasonable hours.

Section 2. All ordinances of a general and permanent nature enacted on or before October 31, 2025, and not included in the Code or recognized and continued in force by reference therein, are repealed.

Section 3. The repeal provided for in section 2 hereof shall not be construed to revive any ordinance or part thereof that has been repealed by a subsequent ordinance that is repealed by this ordinance.

Section 4. Unless another penalty is expressly provided, every person convicted of a violation of any provision of the Code or any ordinance, rule or regulation adopted or issued in pursuance

thereof shall be punished by a fine of not more than \$1,000; or imprisonment in jail for not more than 179 days; or both such fine and imprisonment not to exceed (a) and (b) above.

Each act of violation and each day upon which any such violation shall continue or occur shall constitute a separate offense. The penalty provided by this section, unless another penalty is expressly provided, shall apply to the amendment of any Code section, whether or not such penalty is reenacted in the amendatory ordinance. In addition to the penalty prescribed above, the city may pursue other remedies such as abatement of nuisances, injunctive relief and revocation of licenses or permits.

Section 5. Additions or amendments to the Code when passed in such form as to indicate the intention to make the same a part of the Code shall be deemed to be incorporated in the Code, so that reference to the Code includes the additions and amendments.

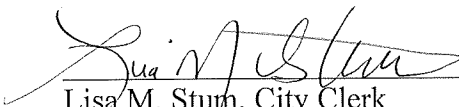
Section 6. Ordinances adopted after the date specified in section 2 hereof that amend or refer to ordinances that have been codified in the Code shall be construed as if they amend or refer to like provisions of the Code.

THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS ADOPTION AND PUBLICATION AS PROVIDED BY LAW.
