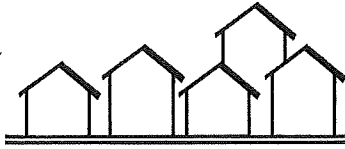

ORDINANCE 838

AN ORDINANCE RELATING TO RATES TO BE PAID BY CUSTOMERS TO THE CITY OF ROSSVILLE, KANSAS, FOR WATER, AMENDING SECTION #15-202 OF THE CODE OF THE CITY OF ROSSVILLE, KANSAS.

Be it ordained by the Governing Body of the City of Rossville, Kansas:

Section I. City Code section 15-202 is hereby amended to read as follows:

15-202 WATER RATES. Water shall be furnished by the city to customers at the following rates per calendar month:

(a) Monthly Base Charge:

- (1) Residential Rates: \$26.00;
- (2) Commercial Customers: Prior to February 1st of each year, the city will determine the amount of water purchased by each commercial customer during the preceding calendar year. Based on such purchases, commercial customers will be charged during each of the ensuing 12 months a monthly base rate as follows:

90,000 to 189,999 gallons	41.00
190,000 to 229,999 gallons	46.00
230,000 to 249,999 gallons	51.00
250,000 to 289,999 gallons	101.00
290,000 to 309,999 gallons	126.00
310,000 to 349,999 gallons	151.00
350,000 to 389,999 gallons	176.00
390,000 to 449,999 gallons	201.00
450,000 to 489,999 gallons	226.00
490,000 to 999,999 gallons	301.00
1,000,000 to 1,499,000 gallons	526.00
1,500,000 to 1,999,999 gallons	626.00
2,000,000 to 2,999,999 gallons	726.00
3,000,000 to 3,499,000 gallons	801.00

3,500,000 to 3,999,999 gallons	901.00
4,000,000 & Over gallons	1,001.00


(b) Monthly Usage Rates:

- (1) All Customers, 0 to 20,000 gallons: \$2.00 per 1,000 gallons.
- (2) All Customers, usage over 20,000 gallons: \$2.50 per 1,000 gallons.
- (c) The rate for water delivered at the water plant to water customers shall be \$0.25 per 100 gallons.

This ordinance shall take effect after its publication once in the official City newspaper.
